## 1. Legal Structure and Nature of Services

- **AGT is a software platform and online marketplace** that facilitates the posting, browsing, and communication related to the sale and trade of firearms and accessories.
- **We do not broker, facilitate, or process financial transactions for the sale of firearms or ammunition.**
- **We do not take possession of, nor ship or transfer firearms.**
- All funds paid to AGT are for: (1) software subscriptions, (2) advertising services, and (3) enhanced account features.

## 2. Hosting and Jurisdiction

- AGT infrastructure is hosted in **Iceland**, a country with strict data protection and privacy laws.
- **All legal demands for user data or platform intervention must be submitted through the appropriate Icelandic court systems.**
- No extraterritorial subpoena or law enforcement request will be entertained unless validated under Icelandic law.

## 3. Liability Disclaimer

- AGT assumes **no liability for any transaction** or interaction conducted between users.
- You acknowledge that buying or selling firearms is subject to strict local, state, and federal laws. **You are solely responsible for complying with all applicable firearm laws and regulations.**
- AGT is a **classifieds-style listing platform**. We do not verify, validate, or warranty the legality or accuracy of any listing.

## 4. Acceptable Use

You agree to:

- Not post anything illegal, obscene, threatening, or misleading.
- Not use the site to conduct prohibited transactions.
- Comply with all local, state, and federal firearm laws.
- Report any suspicious or illegal activity to AGT staff.

Violations may result in immediate suspension or deletion of your account.

## 5. Subscriptions & Paid Services

- FFL (Federal Firearms Licensee) accounts and select premium features are **subscription-based**.
- Subscription payments are for software access and platform enhancements only, not tied to any firearm sale.
- AGT reserves the right to adjust pricing, feature sets, or cancel subscriptions with advance notice.

## 6. Uptime, Security, and Platform Integrity

- AGT commits to maintaining **99.9%+ uptime** and **industry-standard security protocols**, including encryption, secure data centers, and automated backups.
- Access may be limited temporarily for scheduled maintenance or unforeseen technical issues.
- Users are responsible for securing their own login credentials and accounts.

## 7. Affiliates

- AGT offers a **lifetime 5% revenue share** for every user referred using your affiliate link.
- You can use AGT-provided marketing materials, scripts, and brand assets.
- Affiliates must not engage in deceptive, illegal, or abusive promotional methods.

## 8. Donations and Ethics

- AGT donates **1% of annual net profits** to NGOs and/or verified 501(c)(3) organizations actively fighting **child trafficking**.
- Your use of the platform helps fund this initiative.

## 9. Termination

- AGT reserves the right to terminate any account at any time for violations of these Terms, fraudulent activity, or legal obligations.
